#### 1. President's Welcome – Kirsten Foster

Kirsten welcomed the board and members of the public and wished everyone a Happy New Year. BArb and Sullivan 180 for their work She thanked the Sullivan 180 for the wonderful new street signage at the Liberty Studio. She also thanked Barb Demarest for organizing the outreach to lapsed donors and all who helped with these calls. Kirsten welcomed WJFF's newest staff member Mimi Bradley who is WJFF's Development and Operations manager who started last week! Mimi introduced herself to the board and was welcomed by all.

### 2. Review and Approve Past Minutes – Sally Stuart

### 3. Public Comment Opportunity

Kirsten welcomed Pete Madden the newly elected chair of the CAB and invited him to introduce himself. Pete described his background in journalism and media and he was welcomed by the board members.

### 4. CAB Update

Leila McCullough shared a brief update. The CAB met to elect Pete Madden as its new chair and to plan its work for 2023.

### 5. Staff & Programming Update (Tim)

(See attached presentations.) Sally added to Tim's description of the NFCB CCI initiative which has a value of over \$30,000 in training and resources. She and Tim will share materials and engage the relevant committees in this training and capacity building effort which will span the full year. Topics include strategy and planning; community engagement, governance, building diversity and inclusion, adapting to times of emergencies and crises, both protecting the station and serving the community during emergencies. For calendar for 2023 Tim is pushing the first one air fund drive into April; based on last years experience he believes this will be more successful. There was discussion about how to add Q1 fundraising to the calendar and there are a number of events as well as a focus on-air on monthly donors which we call sound supporters and a staff focus underwriting.

### 6. Finance: Final Review of 2022 Performance (Duncan)

Duncan reported that WJFF's revenues are up and so are the expenses a bit. We expect to end the year with a modest surplus but it is too soon to be certain as our reports are not final.

### 7. Strategic Plan Progress Check In (Clay)

Clay walked the board through the summary goals on the strategic plan. Each Committee reported their progress on the key outcomes for the time period. Clay will enter them in the Strategic Plan tracking form. He asked for updates by the next board meeting, and for people and committees to regularly track their progress on the Tracking Form, which will be shared at the next Board meeting. We will do another major check on progress in June or July.

### 8. DCOC Update (Halle Kho)

Halle explained that the DCOC will meet in person on 2/4 and the events and other plans will be locked down by then. Tim is working with BOCES to have another potential internship. We're working with Manor Ink students to broadcast live in our studio and with Liberty High School on podcasting training. SUNY Sullivan Media Arts students are coming to the studio for a tour and we are exploring potential internship opportunities with them.

The events group is planning several community building events including a Salsa night event at the Hurleyville arts center in April.

There hasn't been planning for an event targeting membership but we can do that. Katie Childs asked how many Sounds Supporters we have and said she would share suggestions with Tim

and Mimi about how to build this donor program. DCOC is working on a Sock Hop event with a youth focus. We may do a special event on Valentines Day weekend. Amy Brightfield is working on a Karaoke night at Cabernet Frank. Callicoon hosted a very successful pride party at the DVYC last year and Krissy is working to involve the station in this event in June 2023.

Tim and the Communications subcommittee of DCOC are working with volunteers on a website review. There will be a meeting with the subcommittee and Patricio to review progress and focus on priorities for this coming year.

Analytics will be shared by 4/1/23. Tim has been providing them to DCOC. Halle explained that we are working to figure out what would be appropriate benchmarks. Because of the seasonal swings month by month tracking is a problem.

New grant proposals are going out to the Knight Foundation and the Park Foundation.

During Q1 we will work with staff and board to help identify new underwriters.

Our fundraising event strategy is going to put more focus into the community awards event. We want to make it bigger and have a stronger strategy. We need to grow more effective and not over promise.

### 9. Personnel Committee Update (Michael Williams)

Personnel is doing Tim's annual performance evaluation. We have reworked the performance evaluation document and will include more of his day to day responsibilities in addition to goals.

### 10. Nom & Gov Committee Update (Barb)

Leif is sending out the 2023 Board member self assessment survey now. This is a way to share about your satisfaction and how we can improve board members' experience. It is a mix of multiple choice, short answer questions. There are five sections and the deadline to complete it is 1/23/23.

### 11. Executive Committee Update (Kirsten)

Kirsten explained that we would like to discuss how WJFF can build its audience, consider terrestrial versus digital transmission and consider what is the future of radio? How do we attract and retain listeners? How do we approach prioritizing how we invest our resource. We would like to dedicate a special meeting to this topic and think this should be an in person

meeting. The Facilities Committee thinks we need to have a decision on the potential new frequencies no later than February. This is because we would need to be broadcasting on the possible new frequencies by early January 2025 and we will need 18 months to order the equipment and get everything up and running.

Thane Peterson urged the board to focus on Pennsylvania. He hopes we will add more board members who can champion the PA perspective. In Thane's opinion PA represents the best potential audience growth opportunities for WJFF.

Kirsten invited staff and others to join this conversation.

### 12. Facilities Committee Update (Mike)

Scott Fybush has recently provided a good deal of information. The committee will meet to review and analyze it.

### 13. Audit Committee Update (Dale)

The audit is coming up and we are pulling together all the requested documents for the auditors.

- NOON MUSIC Upfront Soul, Dr. Martin Luther King Jr. Edition: Sanguine Fromage's annual tribute to the life and work of Dr. Martin Luther King, Jr. with two hours of funk, soul, jazz, and gospel, along with excerpts of Dr. King's speeches and field recordings from the African-American civil rights movement.
- **2p SPEECHES Three Landmark Speeches:** King scholars play excerpts from three of Dr. King's speeches and discuss them: "Selma to Alabama," "Beyond Vietnam," and "The Mountaintop Speech."
