Licenses are available in Narrowsburg and Montgomery. They will expand our terrestrial broadcast footprint. Thane reports that we are no longer working with the consultant from Oregon and he is now in touch with Scott Fybush, who is located in NY.

The agenda for the next BOT meeting will also include updates from the Strategic Planning Work Group, Personnel Committee and Nom & Gov, reporting on the diversity initiative.

Thane Peterson presented a Programming Policy draft for our review. Then it will be presented to the BOT next month and made public in May 2021.

Liberty Studio

The Liberty Capital Campaign has raised \$110K of a \$300K goal.

We discussed the potential broadcast equipment expenses for the move to Liberty and Tim Bruno reports he has gotten quotes from two sources.

Tim Bruno reports that BOCES students will be back on their regular schedules in April and will return to the in-kind work on construction at the Liberty studio. Phase 1 of the project should be complete by June 2021.

Tim Bruno requests office support for the ongoing Capital Campaign to manage communications with donors and to learn the donor software Kindful. He suggests it would be about 20 hrs per week for \$15 per hr. for the length of the campaign. Approximate expense of \$5K. He asks for recommendations.
